TO ALL European Archery Member Associations,
Dear President,

As Chair of the Local Organising Committee (LOC) of the **European Youth Championships** to be held in Rome, on 16 to 26 July 2026, I would like to invite you all to be part of one of the most important archery events to take place in the Europe in 2026.

Rome is a vast and layered metropolis, stretching across roughly 1,285 square kilometers, making it one of the largest cities in Europe by area. Its size is not just a matter of numbers but of texture: ancient ruins, Renaissance palaces, bustling neighborhoods, and quiet suburban districts all spread outward like ripples from a stone dropped in history. Unlike cities that grow in neat grids, Rome expands in a more organic, almost poetic way, shaped by centuries of empire, religion, and daily life. Moving through it can feel less like crossing a city and more like traveling through different eras stitched together.

Yet Rome's greatness is not only horizontal but also vertical in time. Beneath modern streets lie layers of earlier civilizations, giving the city a sense of depth that few places can match. Its population of nearly three million people inhabits a space where monumental landmarks coexist with ordinary routines, creating a scale that is both grand and intimate. Rome is large enough to feel endless, yet each district carries its own identity, making the city resemble a constellation of small worlds orbiting a shared, ancient heart.

Over the past decade, Rome has established itself as a remarkable stage for world-class archery events, consistently hosting competitions of extraordinary scale and prestige. The city has welcomed Italian National Championships with more than 1,500 participants, transforming its venues into vibrant arenas of precision and passion. In 2017, Rome shone on the global scene by hosting the Archery World Cup Final, drawing the sport's elite athletes into its historic setting. Its commitment to inclusivity and excellence is further reflected in the organization of two European Para Archery Championships, three Para Archery European Cups, and two editions of the Roma Archery Trophy. Together, these events have turned Rome into a true crossroads of international archery, where ancient grandeur meets modern sporting excellence.

*As per World Ranking requirements it is mandatory to schedule at least gold medal matches for each individual category in a separate 1-hour session for broadcast.

PRELIMINARY & FINAL REGISTRATION

All entries, accommodation reservations, transport needs, flight arrival/departure information and visa invitation letter requests are to be completed using the World Archery Online Registration System WAREOS <https://extranet.worldarchery.sport>. This system handles the entire registration process for this event. No entry forms, hotel reservations or transportation forms will be accepted; all information must be entered into WAREOS.

Member associations can login to WAREOS at <http://extranet.worldarchery.sport> with the username and password assigned by World Archery. After entering WAREOS, selecting the event from the list will allow a member association to register their athletes. Select/press the “Entries” button to see the list of categories in the event. Select/press the “category” to enter the athlete and official numbers/details participating for that event. A WAREOS User Manual can be downloaded in PDF format (English) upon login.

Contact wareos@archery.sport with any questions regarding **technical problems on WAREOS**. For any question regarding the organisation of the event (transport, accommodation, meals, invoices, visa etc.) please contact **directly the LOC**.

A maximum number of three (3) athletes per country can be registered into each category and divisions of the event.

Member Associations can only use WAREOS to make any changes, amendments or cancellations to entries and will be able to do so at any time. An email will automatically notify the Organising Committee and Member Association of any changes made in WAREOS.

Member Associations that have penalty fees outstanding from 2024 will need to have paid these penalty fees before being eligible to enter and compete.

Any entries received after the final registration deadline will be refused. Only substitution will be allowed.

Entries and substitutions received after the deadlines are subject to penalties as clearly stated in the rule book and the world ranking event invitation documents. A Member Association that has made final entries in WAREOS and does not participate will be invoiced for the number of entries entered in the system as well as any other booking they made through the platform (including but not limited to accommodation, transportation, and any other extras the Member Association has booked through the platform).

ACCOMMODATION

The concept of the event is designed to bring all participants together in a single location, creating a seamless experience where they can train, compete, eat, relax and, why not, have fun as well. The goal is to avoid long hours spent on buses or early departures at dawn just to deal with traffic and delays. For this reason, after carefully evaluating several options, the Local Organizing Committee has selected Roma Capitol Village, a four-star camping resort whose greatest strength lies in its vast green area, perfectly suited to host all competition fields and the necessary support facilities in one place.

The scale of the competition will ensure that a large portion of the venue is dedicated exclusively to participants, while still leaving ample space to accommodate accompanying persons, parents, and anyone else interested in being part of the event atmosphere.

Instead of choosing between hotels of varying cost and convenience, participating nations will be able to select from a range of small on-site accommodations, each offering different levels of space and services. This way, it will be possible to opt for anything from a three-room bungalow for up to six people to a single room in a double unit, depending on each team's needs and preferences.

In some cases, it will even be possible to choose more cost-effective options, such as a double bed instead of two single beds, or, on the contrary, opt for a more comfortable solution by assigning a double room to a single participant. For this reason, in addition to what is booked through WAREOS, we strongly recommend getting in touch with our highly professional staff, who will be happy to help identify the accommodation that best suits each team's specific needs.



Rooms are allocated on a first come, first serve basis. Accommodation includes breakfast and lunch with non-alcoholic drinks. Lunch and dinners will always be served in the lunch area of the village according a specific time schedule.

A secure bow storage will be available in the area allocated between practice and competition field. The bow storage is free of charge. Considering the easy walking between rooms, breakfast area and field we strongly recommend to use the bow storage for equipment recovery. The security is granted also during night times.

WEATHER

In Rome, July and August bring long, sun-drenched days and consistently warm temperatures, often ranging between 25°C and 35°C (77°F to 95°F). The air can feel quite dry and fresh water will be a good friend. For this reasons we will try to place competition timings early in the morning with a long lunch break.

Introduction

The Member Association acknowledges to have understood and accepted in their whole and without any restrictions the sale and purchase terms and conditions of this invitation package, and of the registration platform <https://extranet.worldarchery.sp/wareos/>.

Consequently, the Member Association who wishes to register to an event, and book some or all associated extras proposed by the local organizing committee acknowledges that they are fully aware present terms and conditions are accepted by entering information in WAREOS.

Any Member Association declares that it is entitled to enter a contractual relationship with the Local Organising Committee of the event, in accordance with these terms and conditions.

The Local Organising Committee commits itself to communicate, within reason, to its potential clients the greatest information available on the following topics:
Description of the main characteristics of the proposed products and of their use.

Pricing

Information on the methods of payment and reimbursement conditions.

Article 1: Entirety

The platform <https://extranet.worldarchery.sp/wareos/> is the propriety of, has been designed and created and is managed by World Archery Federation at Lausanne, Switzerland, and put at the disposal of the Local Organising Committee to facilitate registration to World Archery events.

The present terms and conditions include any and all rights and obligations of the parties. No single, specific, or general term or condition that may appear on documentation sent, given, or handed over to a Member Association will alter, replace, or complete parts of or the entirety of these terms and conditions. World Archery reserves the right to modify at any time and without any preliminary notification of any kind these terms and conditions.

Article 2: Object

The present terms and conditions define the rights and obligations of the parties in relation to the registration made through the platform <https://extranet.worldarchery.sp/wareos/> of services offered by the Local Organising Committee in the scope of the event it has been set for.

Article 3: Contractual documents

The present terms and conditions and the registration process

make up the contractual documents between the parties.

Article 4: Electronic signature:

The Member Association's entering registration information is the electronic signature which is binding between the parties in the same sense as a handwritten signature would be.

Article 5: Registration

Confirmation – Contract

The contract is validated as soon as the Member Association has entered its preliminary registration by entering information in WAREOS. A modification of the registration is possible until the deadline for registration set in the document. Modifications may be subject to penalty fees.

Article 6: Prices

The official prices are listed in the "Policies and Procedures Athletes, officials and team management", the invitation package prices will be based on the official price list, converted to the currency elected by the LOC for invoicing (CHF, EUR, or USD). The official prices valid on the date that the registration confirmation is sent to the Member Association are binding between the parties.

Article 7: Payment methods

All payments shall be made by bank transfer to the organising committee respecting the stated deadlines, with all bank charges paid by the Member Association.

For any open invoices that are not settled 21 days prior the beginning of the event, the Local Organising committee will be entitled to charge a 5% surcharge on all open amounts.

Any payments received cash by World Archery on behalf of the organising committee will incur a 10% additional service fee, to be paid to World Archery.

Article 8: Payment deadlines and refunds

After the preliminary's entry deadline, the downpayment of 50% shall not be reimbursable. After the final deadlines of registration mentioned in this document, Member Association will not be entitled to any refund, and all remaining unpaid amounts shall be paid to the Local Organising Committee. Failure to do so, will result in an immediate suspension of the Member Association, who will be set as not in good standing on the day of the official practice of the event, and so until the full amount is paid to the LOC.

Article 9: Availability of services

The availability of services is guaranteed on a first come, first serve basis, provided that the

payment of such service has been paid to the local organising committee, partially or in full as mentioned in this document.

The local organising committee is not required to hold services for a Member Association that as not paid in full such service.

Article 10: Force-majeure

None of the two parties will have failed in their respective contractual obligations if their execution is delayed or prevented by a case of force-majeure. Cases considered to be a force majeure are extraordinary events or circumstances beyond the control of the parties, such as a war, strike, riot, crime, or an event described by the legal term "act of God" (e.g., flooding, earthquake, volcano eruption, etc). However, force majeure is not intended to excuse negligence or other malfeasance of a party, as where non-performance is caused by the usual and natural consequences of external forces, or where the intervening circumstances are specifically contemplated. The party experiencing a force majeure must notify in writing with 24 hours after becoming aware of the occurrence. The

parties will then, within 7 business days examine, unless the force majeure prevents it, if and how the contractual obligations will be met.

Article 11: Privacy statement

All information exchanged by the Parties will be treated with the utmost confidentiality. All information requested by World Archery and the Organising Committee from the Member Association are necessary to process the event registration and can therefore be communicated only to the contractual partners of World Archery and the Local Organising Committee.

World Archery and the Local Organising committee are authorized to send informative and promotional e-mails to the Member Association, using the WAREOS e-mail address and the contact person provided by the Member Association during the registration.
